

Froggy 98 -KFGE Rock the Ocean Getaway CONTEST Rules Addendum

These contest rules are specific to the KFGE “Rock the Ocean Getaway” (the “Contest”) conducted by NRG Media, LLC d/b/a KFGE (the “Company” or the “Station”). These rules are intended to supplement the General Contest Rules, however, to the extent that the General Contest Rules differ from these rules, these rules will govern and control with respect to this Contest. A copy of these specific contest rules and the Station’s General Contest Rules are available at the Station’s studio at 4343 O Street, Lincoln, NE during normal business hours of 8:00 a.m. to 4:00 p.m., Monday through Thursday and 8:00 a.m. and 4:30 p.m. Friday, and on the contest page on the Station’s website at <http://www.froggy981.com>.

The Rock the Ocean Contest will run from October 22nd through November 9th, 2018. The Prize winner will be required to use the prize on April 11-15, 2019.

Listeners must be at least 21 years of age and reside within 50 miles of the Station’s studio to enter and win this contest or attend as a guest of winner.

How to Play:

There are three ways to qualify as a finalist for the Grand Prize drawing.

1. You can enter through the Froggy 98 Country Club. If you are already a member, login in and complete the entry form to register to win the “Rock the Ocean Getaway” contest.

If you are not already member, join the *Froggy 98 Country Club* now at www.froggy981.com and complete the entry form to register to win the “Rock the Ocean Getaway” contest.

Once you register, your name is in the drawing for the contest for the length of the contest. You only need to enter once.

Then listen for your name to be called at 8AM, 11AM and 3PM Monday through Friday starting October 22nd. Froggy will announce a name from the entries in the “Country Club” The listener will have two (2) minutes to call back in after hearing their name to win a qualifying prize and be entered in the Grand Prize drawing. The studio line to call is 402-474-3764. If the listener does not call back in within the allotted time, they will not win a qualifying prize or be entered in the Grand Prize drawing. Their name will be returned to the qualifiers pool and could be drawn again.

If the listener calls back in the allotted timeframe after hearing their name, Froggy will spin the wheel of prizes and they will instantly win a qualifying prize. The prizes will include concert tickets, dinner certificates and cash. They will also be entered into the Grand Prize drawing occurring on Friday, November 9th.

Due to the time delay that exists between the station's analog over-the-air single and the station's online webcast, listeners who listen to the station online may hear it later than those listening to the station's analog over-the-air single. As a result, the odds of an online listener winning this contest may be diminished.

Value of the qualifying prizes range from \$100 to \$300 depending on prize.

2. Listeners may also enter the Grand Prize drawing by listening for the TEXT KEYWORD at 8AM, 11AM and 3PM. Text the keyword and your name to 68255. One TEXT qualifier will be drawn after each of the daily qualifying times (Mon-Fri) at 8:15AM, 11:15 AM and 3:15PM to become a qualifier for the Grand Prize Trip. You may receive a reply text to confirm your entry. If you or a daily qualifier or win the Grand Prize, the station will call the phone number you texted from to notify you. By texting an entry, you give the station permission to call you at that number and receive a reply text.

3. Listeners who don't want to join the club or text may send an entry that contains their name, address, phone number, email address, and date of birth to KFGE ROCK THE OCEAN GETAWAY CONTEST ENTRY, 4343 O Street, Lincoln, NE 68510. Mail entries will be added to the Grand Prize Drawing pool. Mail entries must be received by November 7th to be entered into the drawing.

On Friday, Nov 9th, KFGE will randomly draw from the people Grand Prize qualifiers (the club qualifiers, the text qualifiers and the mail-in entries) and award the trip. The winner will be notified by phone by the station.

The Grand Prize is: Roundtrip airfare for two (2) from Omaha to Fort Lauderdale, Florida on April 11th, 2019, a four night stay for 2 in a double occupancy room in a hotel of station's choosing, general admission for two (2) to the Tortuga Music Festival on the beach in Florida, and hotel transfers. You must be able to travel April 11 – 14, 2019. Dates and prize are non-transferrable and cannot be changed.

Value of the Grand Prize is approx. \$3,200. No substitutions or cash value.

The Grand Prize winner is responsible for paying all applicable taxes and will be issued an IRS 1099 form.
